Program Overview:

- Learn about American law from prominent American judges, professors, and other legal experts

Curriculum:

60 hours of classroom-based instruction (Mon - Fri from 9:00 a.m. to 1:00 p.m.) plus daily extracurricular activities. Courses include:

- **Introduction to the American Legal System**
- **International Law and Relations**
- **International Business and Trade Law**
- **Regional Economic Integration in Comparison**
- **English for Legal Professionals**

In addition to classroom-based lectures, workshops on TOEFL preparation, academic research and writing, and other subjects of interest will be included.

Any interested student is encouraged to apply. This program is particularly suitable for advanced undergraduate students in law, graduate and post-graduate students, professionals seeking to upgrade and update their knowledge in International & Comparative law and/or their skills in professional English, and anyone considering Master of Laws (LL.M.) studies in the United States.

Participation Fee: \$1,000 USD, includes all courses, workshops, visits to courts and law firms, other extracurricular activities and events (\$500 USD due within 3 weeks of admission; \$500 USD due upon arrival).

Additional Expenses Incurred by Participants: Visa application fees (if applicable); transportation to and from Indianapolis; accommodations while in Indianapolis; sightseeing and cultural activities, meals and incidentals.

In the event of a cancellation, all program fees and deposits will be refunded. If the applicant cancels after acceptance into the program and the deposit fee has been paid, no refunds of any payment will be made, except in extenuating circumstances.
